#### RESOLUTION CALLING PARCEL TAX ELECTION

WHEREAS, Section 4 of Article XIIIA of the California Constitution and Government Code Section 50079 authorize a school district, upon approval of two-thirds of the electorate voting on the measure, to levy a qualified special tax for specified purposes; and

WHEREAS, the Board of Trustees (the "Board") of the Orinda Union School District (the "District") has determined that in order to continue meeting the educational needs of all of the District's students, it is necessary to authorize an additional parcel tax; and

WHEREAS, the District is committed to maximizing State and federal funding, and relying on local parcel taxes only as needed in order to meet its stated educational goals; and

WHEREAS, the Board has held a public hearing after due notice regarding the proposed authorization of the parcel tax.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Orinda Union School District, as follows:

- 1. <u>Recitals.</u> This Board hereby finds and determines that the foregoing recitals are true and correct.
- 2. Order of Election. This Resolution shall stand as the order to the Contra Costa County Superintendent of Schools to call an election within the boundaries of the District on March 3, 2009, for approval of the measure contained in Section 3 hereof. The authority for the specifications of this election order is contained in Sections 5304 and 5322 of the California Education Code and Section 50079 of the California Government Code.
- 3. <u>Specifications of Ballot Measure</u>. This Board hereby requests the Registrar of Voters of the County of Contra Costa (the "Registrar of Voters") to submit to the voters of the District on March 3, 2009, the following ballot measure:

# ORINDA ELEMENTARY AND INTERMEDIATE SCHOOLS EXCELLENCE IN EDUCATION PRESERVATION ACT OF 2009

This Proposition may be known and referred to as the "Orinda Elementary and Intermediate Schools Excellence in Education Preservation Act of 2009" or as "Measure \_\_\_\_\_." [Designation to be assigned by County Registrar of Voters]

#### **FINDINGS**

The Orinda community values educational excellence both for our children and for the continued attractiveness of Orinda as an exceptional place to live and own a home.

Orinda Union School District is determined to maintain its support for strong academic programs, quality teaching, and small class sizes.

State and federal funding levels will not permit the District to continue to achieve its high goals for our children's education. Local sources of funding continue to be needed to preserve classroom programs, but contributions through the Educational Foundation of Orinda, Parent Clubs, and other local sources, while significant, are not enough. Nor should we as a community expect to rely on annual voluntary contributions to satisfy the District's ongoing basic operational costs and need to pay fair teacher salaries.

A secure, reliable source of non-State funding is needed to maintain high academic standards and provide the best education program possible to the children of Orinda, to attract and retain the best teachers available, and to preserve small class sizes.

## TERMS OF PRESERVATION OF EXCELLENCE IN EDUCATION 2009 SPECIAL TAX

Terms and Purposes. Upon approval of two-thirds of those voting on this measure, the District shall be authorized to levy a qualified special tax of \$124 per year on each taxable parcel in the District, to supplement the District's existing parcel tax, commencing July 1, 2009. The qualified special tax shall be known and referred to as the "Preservation of Excellence in Education 2009 Tax." Proceeds of the Preservation of Excellence in Education 2009 Tax shall be authorized to be used for sustaining classroom and educational program improvements, such as by reducing the impact of state budget cuts; maintaining small class sizes and neighborhood schools; attracting and retaining skilled, qualified teachers with competitive compensation and training; and protecting classroom programs and strong core academics; with no funds used for administrators' salaries.

Low-Income Senior Citizen Exemption. In order to provide tax relief to those members of the Orinda community most in need, any parcel owned and

occupied by a low-income person 65 years of age or older shall be exempt from the Preservation of Excellence in Education 2009 Tax upon proper application to the District. The exemption shall be available pursuant to procedures to be prescribed by the Board of Trustees or otherwise as required by law or by the Contra Costa County Tax Collector. A "low-income person" is a member of a "very low income household" as defined by California Health and Safety Code Section 50105. Under current law, this means any household whose income does not exceed 50 percent of area median income, adjusted for family size and revised annually.

#### **ACCOUNTABILITY PROVISIONS**

Independent Annual Audit. Upon the levy and collection of the Preservation of Excellence in Education 2009 Tax, the Board of Trustees shall cause an account to be established for the deposit of the proceeds. For so long as any proceeds of the Preservation of Excellence in Education 2009 Tax remain unexpended, the Superintendent or chief financial officer of the District shall cause an independent financial auditor to prepare a report to be filed with the Board of Trustees no later than January 1 of each year, commencing January 1, 2010, stating (1) the amount of Preservation of Excellence in Education 2009 Tax received and expended in such year, and (2) the status of any project funded or to be funded from proceeds of the Preservation of Excellence in Education 2009 Tax. The report may relate to the calendar year, fiscal year, or other appropriate annual period, as the Superintendent shall determine, and may be incorporated into or filed with the annual budget, audit, or other appropriate routine report to the Board of Trustees.

Independent Citizens' Oversight Committee. As an additional accountability measure, the Board of Trustees will appoint or designate an independent oversight advisory committee of citizens to ensure that the special tax proceeds are spent for their authorized purposes, and to report annually to the Board of Trustees and the public regarding the expenditure of such funds.

<u>Specific Purposes</u>. All of the purposes named in the measure shall constitute the specific purposes of the Preservation of Excellence in Education 2009 Tax, and proceeds of the Preservation of Excellence in Education 2009 Tax shall be applied only for such purposes.

#### LEVY AND COLLECTION

The Preservation of Excellence in Education 2009 Tax shall be collected by the Contra Costa County Treasurer-Tax Collector at the same time and manner and shall be subject to the same penalties as ad valorem property taxes collected by the Treasurer-Tax Collector. Unpaid taxes shall bear interest at the same rate as the rate for unpaid ad valorem property taxes until paid. The collection of the Preservation of Excellence in Education 2009 Tax shall not decrease the funds available from other sources of the District in any period from the effective date hereof.

"Parcels of taxable real property" shall be defined as any unit of real property in the District which receives a separate tax bill for ad valorem property taxes from the Contra Costa County Treasurer-Tax Collector's Office. All property which is otherwise exempt from or on which are levied no ad valorem property taxes in any year shall also be exempt from the imposition of the Preservation of Excellence in Education 2009 Tax in such year. An exemption is provided for low-income seniors as described above.

The District shall annually provide a list of taxable parcels to the Contra Costa County tax collection officials. The Contra Costa County Assessor's determination of exemption or relief of any such taxable property from taxation shall be final and binding for the purposes of the Preservation of Excellence in Education 2009 Tax. Taxpayers wishing to challenge the County Assessor's determination must do so under the procedures for correcting a misclassification of property pursuant to Section 4876.5 of the California Revenue and Taxation Code or other applicable procedures. Taxpayers seeking a refund of Preservation of Excellence in Education 2009 Taxes paid shall follow the procedures applicable to property tax refunds pursuant to California Revenue and Taxation Code.

To the extent allowed by law, the District shall adopt administrative procedures by resolution of the Board of Trustees to allow exemption from the Preservation of Excellence in Education 2009 Tax for multiple contiguous parcels not designated for development and other defined categories of parcels, taxation of which is determined to be unfair.

#### **SEVERABILITY**

The Board of Trustees hereby declares, and the voters by approving this measure concur, that every section and part of this measure has independent value, and the Board of Trustees and the voters would have adopted each provision hereof regardless of every other provision hereof. Upon approval of this measure by the voters, should any part be found by a court of competent jurisdiction to be invalid for any reason, all remaining parts hereof shall remain in full force and effect to the fullest extent allowed by law.

4. <u>Summary of Measure</u>. The measure contained in Section 3 hereof shall be summarized, and the Registrar of Voters is requested to cause the summary of the measure to appear on the ballot, in the following form:

"To provide secure local funding for all Orinda K-8 students; reduce the impact of state budget cuts; maintain small class sizes and neighborhood schools; attract and retain skilled, qualified teachers with competitive compensation and training; and protect classroom programs and strong core academics, shall the Orinda Union School District be authorized to levy a parcel tax of \$124

per year per parcel, with citizen oversight, no funds used for administrators' salaries, and every dollar staying in Orinda Union schools?" L'School Dutuck

- 5. <u>Filing of Order of Election</u>. The Secretary of this Board is ordered to cause certified copies of this Resolution and order to be delivered not later than December 5, 2008, to the Contra Costa County Superintendent of Schools, the Registrar of Voters, and the Clerk of the Board of Supervisors of the County.
- 6. Formal Notice. The Contra Costa County Superintendent of Schools is hereby requested to prepare and execute a Formal Notice of Parcel Tax Election and consolidation order in substantially the form attached hereto as Exhibit A (the "Formal Notice"), and to call the election by causing the Formal Notice to be posted in accordance with Section 5362 of the Education Code no later than December 6, 2008, or to otherwise cause the notice to be published as permitted by law. The Secretary of this Board, on behalf of and as may be requested by the County Superintendent of Schools, is authorized to cause all notices required by law in connection herewith to be published and posted, as the case may be.

#### 7. Conduct of Election.

- (a) Request to Registrar of Voters. Pursuant to Section 5303 of the Education Code, the Registrar of Voters if requested to take all steps to hold the election in accordance with law and these specifications.
- (b) Voter Pamphlet. The Registrar of Voters is hereby requested to reprint the measure in its entirety (that portion of Section 3 hereof which is printed in bold-face type) in the voter information pamphlet to be distributed to voters pursuant to Section 13307 of the Elections Code. In the event the measure in Section 3 will not be reprinted in the voter information pamphlet in its entirety, the Registrar of Voters is hereby requested to print, immediately below the impartial analysis of the measure, in no less than 10-point boldface type, a legend substantially as follows:

"The above statement is an impartial analysis of Measure \_\_\_. If you desire a copy of the measure, please call the Contra Costa County Registrar of Voters at [phone number] and a copy will be mailed at no cost to you."

- (c) Consolidation. The Contra Costa County Superintendent of Schools and the Board of Supervisors of the County are requested to order consolidation of the election with such other elections as may be held on the same day in the same territory or in territory that is in part the same.
- (d) Canvass of Results. The Board of Supervisors of the County is authorized to canvass the returns of the election pursuant to Section 10411 of the Elections Code.

- **8.** <u>Appropriations Limit.</u> The Board of Trustees shall provide in each year (pursuant to Section 7902.1 of the Government Code or any successor provision of law) for any increase in the District's appropriations limit as shall be necessary to ensure that proceeds of the Preservation of Excellence in Education 2009 Tax may be spent for the authorized purposes.
- 9. <u>Ballot Arguments</u>. The President of this Board, or any member or members of this Board as the President shall designate, is hereby authorized, but not directed, to prepare and file with the Registrar of Voters, a ballot argument in favor of the proposition contained in Section 3 hereof, and a rebuttal to any argument filed against the proposition, within the times established by the Registrar of Voters, which shall be considered the official ballot argument and rebuttal of this Board as sponsor of the proposition.
- 10. Official Actions. The District Superintendent, President of the Board, or their designees are hereby authorized to execute any other document and to perform all acts necessary to place the Measure on the ballot, including making alterations to the specifications of the ballot measure stated in section 3 above, the summary of the ballot measure stated in section 4 above, or otherwise to this Resolution, to comply with requirements of law and election officials or which are, in their judgment, in the best interests of the District.
- 11. Effective Date. This Resolution shall take effect from and after its adoption.

## Orinda Elementary and Intermediate Schools **Excellence in Education Preservation Act of 2009**


